It aims to reach the ultra-poor rural women with complementary inputs to be self-reliance through improving their nutritional status and livelihoods. The programme is being coordinated by the Ministry of Women and Children Affairs and implemented by the Department of Women Affairs with the support of UNWFP, the European Commission and the governments of Australia, Canada, Germany and France.

RDA, Bogura conducted the impact evaluation of the programme cycle 2009-2010. Having been involved with DelPHE since 2010, Bindura University partnered Northumbria University (UK) and BRAC University (Bangladesh). The three worked on a disaster management project which has changed the landscape and approach to disasters in Zimbabwe.

The conducted tasks for the project were to: (a) organise several meetings in UK and Bangladesh, and an international conference in Zimbabwe; and (b) conduct in-depth interviews in Muzarabani, Zimbabwe.

This main aim of the project was to assess how health influences vulnerability to major disaster events. This was to contribute to a goal of poverty and disaster risk reduction through improved health security. The following overall research objectives were developed centred on the case of Bangladesh to: (a) identify how health security influences vulnerability and resilience to disasters; (b) assess how health security monitoring can facilitate early warning and preparedness against changing thresholds of disaster risk; and (c) evaluate which approaches to health security enable people to monitor resilience as an aid to mitigating the impact of disaster events.
